Enclosed you will find statements of the 2021 and 2022 LIGA Assessments.

After the mailing of the 2021 assessment invoices in December, it was determined that two lines of business (private crop and private flood) were omitted from the premium total. Additionally, a credit was not provided for policyholder dividends. These corrections, if applicable, are enclosed along with record of payments received to date. LIGA expects to issue Certificates of Contributions for all receipts in August.

We have also included the new 2022 Assessment statement. The balance due includes 1 % of the direct written premium for 2021 premiums less policyholder dividends.
